Rules and regulations to adhere to when renting stand or space at regatta 2024:

1. To register for a stand a form has to be filed
 - a. Online or on a hardcopy. (www.regattabonaire.com)
2. Last day to register will be September 13th 2024.
3. The renter must mention what he/she will bring for electronics equipment
4. The participation amount will have to be paid before September 20th 2024.
5. The amount must be deposited via bank on MCB 10104440 in the name of Tourism corporation Bonaire before the 20th of September 2024.
6. All registered participants must pay a deposit of \$100,-. (non refundable)
7. If the participation amount is not paid according to the deadline, your registration will be canceled
8. In case of cancelation there will be no refund
9. The stand must have a visible name of the company/concept and should be decorated
10. The participant must have a visible menu display including prices.
11. All participants must submit their menu for approval before 13th of September 2024. (Menu's will be displayed online for promotion)
12. **It's not permitted** to sell any kind of beverage.
13. **It's not permitted** leave oil or charcoal ashes on the ground (there will be special garbage cans to make sure u dispose your flammable items properly)
 - a. TCB reserves the right to immediately stop all operations due to non-compliance
14. If the renter does not comply with the rules and regulations the organization is allowed to ask to leave the stand or space and the renter will lose their deposit.
15. Also the renter will be put on the blacklist and can not participate in the next Regatta.
16. Organization (TCB) will not be responsible for any loss or damage to your materials
